**MOTION:**

**NEW BUSINESS:** The Board and guests discussed people posting things on the bulletin boards from outside of the subdivision and taking down things that do belong on the boards. The Board agreed to lock the bulletin boards and put up a notice that everything from the community needs to be approved before it will posted.
