The meeting was called to order by President Richard Lingk at 7:00 p.m. October 8, 2013.

Each Director read the Minutes of the September Meeting.

MOTION:

Ernie DeWinne made a motion to accept the September Minutes as presented.

TREASURER REPORT: The Board and guests went over the Balance Sheet and Profit and Loss report presented by Ernie DeWinne. There is a total of \$133,334.78 in checking and savings as of September 30, 2013.

CORPORATE SECRETARY: . EXECUTIVE SECRETARIES REPORT: Karen Brucks reported that we are receiving a lot of ballots, we are going through everything to see what we need to purchase for the annual meeting, the Pate's once again have donated plates.

MAINTENANCE REPORT: The Board read over Joe's report that the security cameras have now been installed and working property, thanks to Harry Maxwell for all his help and expertise. Joe reported that he has put all the pool furniture and signs away for the season, mowing for the annual meeting. Joe reported that he has the base ready and leveled out for the storage tank that the BRRWSC is letting us use to catch all the backwash water from the pool, so we can use this to water the grass at the pool and will be available for the fire department to use if needed.

ACC: Wayne Mauldin reported that the ACC has approved one new home, a patio cover, a well house, a fence and a shed since the last Board Meeting.

AUDIT COMMITTEE: Richard Lingk reported that the committee completed the audit last month and will report at the Annual Meeting.

OLD BUSINESS: The Board and guests discussed that they were happy that they have seen more presence of the sheriff's department in our subdivision.

The Board went over the changes to the Employee Policy.
